White Salmon Pool Committee: Are looking to house money in a CEKC project account. They have had a \$55K donation for a feasibility study which is completed. The pool loses about 10,000 gallons of water a day and really isn't fixable. There is also a \$100K donation from another source. The City of White Salmon has applied for a \$500K grant but there is lots of competition for it. They would like to put it on a bond proposal on the ballot, which the City of White Salmon would float. The project is an estimated \$3.2 million project.

Bruce made a motion to approve City of White Salmon as a project contingent upon paperwork and compliance with CEKC bylaws, Darla seconded, motion passed.

Troy: Goldendale Observatory- Has received a large amount from the state out of the capital budget for upgrades to the facility. This grant cannot be used for things, has to be brick and mortar items. Troy is applying for 3 different grants (\$14k, \$20K, \$30K) but is competing with the State Parks for these. This is the third phase of renovations, phase 4 will be in 2017. This could be another Agora project.

Sharon Carter: are having trouble getting the dental surveys back. They are looking for grants that will allow them to purchase additional preventative equipment. It was suggested to put the survey on Facebook and with the Transportation Committee.

Sharon is also writing grants to fund a fixed transportation route east/west of the county. There is an "Aging Mastery" session starting gin Goldendale and there will be one more "Aging Mastery" in the spring.
