**Minutes:** Bruce made a motion to accept the minutes, Darla seconded, motion passed.

**Treasurers Report:** Barb made a motion to accept report, Bruce seconded, motion passed.

**Sr Living Fund-** There are some issues w/the dispersal of funds prior to our involvement. Original contract for dispersal called for money to go to SW Washington Humane Society and ASPCA- New York from real estate sale on a time schedule. Real estate contact was fulfilled early due to increased payments but donations to SWHS and ASPCA- NY were not increased appropriately. Sharon is figuring it out and will let us know the final totals. White Salmon Senior paid one portion but CEKC will have to reimburse and make any other necessary payments.

**Gorge Kitten Project -** We need to follow up on our 5%

**Trout Lake School District:** received donation from Amway which will go thru CEKC.

**Senior Services -** Sharon should find out by the 18th about the Aging Mastery Grant and the Hygienist Grant. She is trying to find a hygienist who will commit to this project. We are still putting the Scam/ID Theft workshop together. Tentative date is in March.

**Economic Development-** Saving Skamania County, a community organization, has submitted a Project Support Form and would like to be put on January's agenda.

**SCORE-** a small business mentoring program is active in Skamania County through the EDA office. Pat will check and see if they would consider coming to Klickitat Co.

All the Port Industrial Properties are rented.

The Wind River nursery site in N. Bonneville is being considered by the port as a site for a major marijuana grow operation. Would fund 30-40 fully benefitted full time jobs.

**AGORA -** Linda received email from Mark with requests/guidelines on how to proceed. Golden dale, White Salmon and Lyle were chosen as outreach communities.

Need to define the target audience: schools, churches, fire dept.'s non-profits, chamber of commerce, county government.

Need to identify target contributors: businesses, casinos, nonprofits, individuals
